Welcome to the [www.feedmilltag.com](http://www.feedmilltag.com) website (the “**Website**”). The Website is made available by Cedar Rock Software LLC, a Wyoming limited liability company (“**CRS**”), and CRS has developed this Privacy Policy to let you know what information CRS collects through the Website and how it is used.

Information We Collect:

CRS collects information you submit to the contact addresses provided on the Website’s contact page (“**Contact Information**”) and through the Website’s subscription registration process (“**Registration Information**”), including your first and last name, company name, street address, email address and any other data submitted in connection with your requests for information about, or help with, CRS’s products and services. CRS may also collect usage and access information through cookies and web beacons on the Website, including device identifying data, your IP address and/or location data.

How We Use Collected Information:

CRS uses the Contact Information to contact you to provide you with information about, or assistance with, CRS’s products and services. CRS uses the Registration Information to set up user accounts and subscriptions for the Website. CRS’s third party providers host the Contact Information and Registration Information and also use the Registration Information to process payments for user accounts and subscriptions for the Website. CRS may also use your usage and access information to send you notifications, updates and advertisements related to the Website.

Third Party Data Collection on the Website:

Third parties may be able to collect personally identifiable information about your online activities when you use or access the Website, including through the use of third party cookies and web beacons. Such third party data collection may occur over time and may be stored with other personally identifiable information collected about you from other websites and/or services. CRS has no ability to control how such third parties store and use your personally identifiable information and is not responsible for you using or accessing any such third party websites and/or services. All third party website access and use is outside the scope of this Privacy Policy and you should review such third party websites’ privacy policies.

How we Share Information:

CRS may disclose your personally identifiable information in order to protect its legal rights, safety, and security, and the users of CRS’s subscription services; enforce CRS’s Terms of Use and Subscription Agreement; respond to and resolve claims or complaints; prevent fraud or take other action regarding illegal activity, suspected fraud or other wrongdoing; and to comply with or respond to law enforcement or legal process or a request for cooperation by a government or other entity, whether or not legally required. CRS may contract with third party companies and individuals to facilitate CRS’s subscription services (e.g. support, analysis, marketing and development). Such third party companies or individuals have limited access to your personally identifiable information only to perform these tasks on CRS’s behalf and are obligated to us not to disclose or use it for any other purposes. If CRS sells all or part of its business, or makes a sale or transfer of assets, or is otherwise involved in a merger or business transfer, or in the unlikely event of bankruptcy, a business reorganization, or similar event, CRS may transfer your information as part of such transaction.

The Website does not take any action in response to a “do not track” signal transmitted by your browser.

Protection of Information:

CRS and/or its third party providers have implemented and maintain physical, administrative and electronic security measures related to the Website that are designed to safeguard both your personally and non-personally identifiable information from improper access or use.

Restrictions on Use:

The Website is intended for adults age 18 or older. The Website is not intended or designed to attract the attention of minors. CRS does not collect personally identifiable information for any person who CRS knows to be under the age of 18.

Changes to This Privacy Policy:

This Privacy Policy may be updated or modified from time to time and should be reviewed by you periodically. CRS will use commercially reasonable efforts to provide notice of any material changes in any such updated or modified version of this Privacy Policy.
